### A Word from the Chair

#### I. Strategic Planning

GIOPS has just finished formulating its Strategic Plan for the next biennium. The Goals and Activities are as follows:

**Goal 1. Continue the Section's ongoing series of professional seminars and training programs in different regions of the world.**

*This relates to the following IFLA Professional priorities: (a) advocacy, (b) partnerships and alliances, (c) continuing professional development.*

**The following Action is planned in connection with Goal 1:**

1.1 Continue work with our colleagues in the Africa Section and with FAIFE to develop and seek funding for an additional seminar targeted to government information specialists, data specialists, and their user constituencies in Africa (West or Sub-Saharan Africa) on the issues, challenges, opportunities, and requirements of print and electronic government services, programs, and information. The seminars will highlight the role these specialists can play in fostering the information literacy essential to maintaining and furthering sound governance practices, accountability, and effective use of these resources.

1.2 Carry out the already planned seminar and workshop in East Africa as initiated with the GIOPS member from the Economic Commission for Africa (EAC) on the role, place, challenges and opportunities provided by the Internet and digitized government information to foster improved regional governance. The seminar and workshop will also highlight how information and data specialists in the region, working cooperatively with their user constituencies and key decision makers, can help to shape the information agenda of governments and provide practical guidance on how to accomplish this.

1.3 Extend the collaboration with the Committee on Free Access to Information and Freedom of Expression (FAIFE) to implement the planned workshop and develop additional seminars and workshops on the creation, promotion, use, support, control, accessibility, preservation, and dissemination of government information globally.

**Goal 2. Expand and enhance the educational tools to users and information professionals in the means of accessing, promoting, organizing, maintaining, using, and preserving government information.**

*This relates to the following IFLA Professional priorities: (c) continuing professional development.*

**The following Action is planned in connection with Goal 2:**

2.1 Continue to review, promote and expand the Government Information and Official Publications Section's (GIOPS) Web-based guides and related resources. Continue to explore opportunities to leverage its potential and develop new products based on it.

2.2 Develop and extend the IFLA GIOPS electronic list-server to further market the activities of GIOPS, opening its membership to a wider audience in order to broaden the base of interest in the work of the Section.

2.3 Edit, consolidate and disseminate in print and electronic form a series of best practices culled from papers presented in the past five years at GIOPS open sessions, requesting updating from the authors as necessary.

2.4 Continue collaboration and participation with the Government Libraries Section in the development of a guide to promote standards and best practices for Government Libraries and Information Centers.

**Goal 3. Examine methods of electronic access to information produced by governments, intergovernmental organizations and public non-governmental organizations.**

*This relates to the following IFLA Professional priorities: (a) advocacy.*

**The following Action is planned in connection with Goal 3:**

3.1 Develop a conference program for the upcoming conferences to promote and highlight the value of government information in fostering education and development, collaborating strategically with other Sections as appropriate.

**Goal 4. Review the role and place of the Government Information and Official Publications Section within IFLA.**

*This relates to the following IFLA Professional priorities: (a) advocacy, (b) partnerships and alliances.*

**The following Action is planned in connection with Goal 4:**

4.1 Continue to review the mission, mandate, scope and objectives of the Government Information and Official Publications Section to ensure that the interests, needs and concerns of international non-governmental bodies can be legitimately covered within the Section. Address any concerns identified.

**Goal 5. Complete a review of the development and publication of position papers, including the Position Paper on Copyright, finalize and implement an approach.**

*This relates to the following IFLA Professional priorities: (a) advocacy, (c) continuing professional development.*

## **The following Action is planned in connection with Goal 5:**

5.1 Initiate a review of current GIOPS position papers and determine whether to carry forward in collaboration as appropriate with other IFLA Groups and Sections.

## **II. Oslo in 2005: IFLA Conference – Libraries – A Voyage of Discovery**

The Government Information and Official Publications Section programme for Oslo was, all agreed, one of the best! In harmony with the Conference theme, the GIOPS programme was entitled: “*Sailing the treacherous seas of digital government information: from pamphlet boxes to digital library*”. ### **Call for Papers – Parliamentary Libraries and GIOPS Sections**

The Government Information and Official Publications Section (GIOPS) and the Parliamentary Libraries Section are sponsoring a joint six hour session on two major themes linked by a bridging session on content management systems, information architecture and web design issues.

We invite proposals for papers addressing two major themes highlighting the role of libraries in the knowledge society:

*Government Information: dynamic energy sources for business (2 hours)*

*The Model E-Parliament: Powerful Force for Positive Change in the Knowledge Society. (2 hours)*

We also invite proposals for a two-hour session on information architecture, content management systems, web design and web usability issues. The challenge is to improve the presentation and design to make complex and difficult topics easier for information consumers.

Three to four presentations covering national and/or regional examples will be selected for each session. The presentations may be in the form of PowerPoint presentations and/or papers, however only full papers will be published. Presenters are expected to make their presentations in person, along with the use of slideshows and handouts. Proposals for presentations, in the form of one page summaries, should be sent by March 30, 2006, to Irja Peltonen, GIOPS 2006 Programme Chair, at [Irja.Peltonen@vm.fi](mailto:Irja.Peltonen@vm.fi), with cc to [jane.wu@fao.org](mailto:jane.wu@fao.org), [sandra.k.peterson@yale.edu](mailto:sandra.k.peterson@yale.edu) and [drueryj@post.queensu.ca](mailto:drueryj@post.queensu.ca).

The proposals should include the name(s), contact information and institutional affiliation(s) of author(s); a summary of the content to be presented; and an indication of the language(s) in which the presentation and any handouts will be made. All proposals will be evaluated by Section Officers who will inform applicants of the results by the end of February 2006. Final versions of the presentations must be submitted to the above addresses by the end of May 2006.

### **Hubbertz Study Highlights Archival Needs for Web-Based Information**

Andrew Hubbertz, Librarian Emeritus, University of Saskatchewan Library and former member of GIOPS, conducted a study under contract to the Canadian Association of Research Libraries entitled "Collection and Preservation of Web-based Provincial/Territorial Government Information: Report on a Survey of CARL and APLIC Libraries." CARL is Canadian Association of Research Libraries and APLIC is Association of Parliamentary Libraries in Canada.

He followed this up with a draft report containing recommendations. Although it has not been adopted as CARL policy, it is available at: [http://www.carl-abrc.ca/projects/preservation/pdf/e-docs\\_report2.pdf](http://www.carl-abrc.ca/projects/preservation/pdf/e-docs_report2.pdf). In the course of doing this work,

he discovered that many libraries were interested in collecting government web-based documents, but had no idea how to get started. The literature can be intimidating --just have a look at the OASIS Reference Model! Hence, he thought it would be useful to compile a 'cookbook' for a basic collection of such material. What he came up with is available at: <http://www.carl-abrc.ca/projects/preservation/pdf/Cookbook.pdf>. It addresses the critical issues. However, in the course of his survey he found that there were a number of provincial and territorial jurisdictions where nothing is being done, and where the resources are extremely limited, e.g. territorial legislature library with a staff of three or four. Rather than let material be lost forever, he thinks it is desirable to do what we can, even if that means making compromises.
