Additional information included the Chair welcome to MLAS Workshop 2011 to be held on Saturday 19<sup>th</sup> February 2011, the second MLAS Workshop after the first successful workshop held in Stellenbosch, South Africa after the 1<sup>st</sup> IFLA Presidential meeting of Ellen Tise, IFLA President. ### Approval of the agenda

MLAS Chair asked for the approval of MLAS SC Meeting agenda in Split, Croatia. MLAS SC meeting agenda was approved after Janice Lachance made sure everybody will attend the both meetings as the presentation of Stuart Hamilton was planned for the second day of meeting.

Maria Cotera/WILSIG Convener proposed the minute of silence on the memory of Bob McKee/CEO of CILIP from United Kingdom, who died during IFLA Annual Conference in 2010. She introduced his life, activities and personality before all MLAS SC members and observers expressed their mourning after Bob McKee during the minute of silence.

Jennefer Nicholson/IFLA Secretary General informed all MLAS SC Mid-Term meeting participants on *CILIP/IFLA Aspire Award*, which was launched in memory of CILIP's Chief Executive Bob McKee. Award will be jointly sponsored by the Chartered Institute of Library and Information Professionals (CILIP) and IFLA. The Award will support Bob's strong interests in developing new professionals and strengthening international relationships by providing bursaries for new professionals to attend CILIP and IFLA conferences. Regarding the unfortunately unfulfilled plans of Bob McKee to be the cotrainer of BSLA programme in Ukraine, IFLA decided to support *CILIP/IFLA Aspire Award* from Ukraine in coming two years.

# **Report on MLAS Project Proposals**

Silvia Stasselová/MLAS Secretary prepared two IFLA Project proposals on behalf of MLAS in October 2010 which were approved by Janice Lachance/MLAS Chair:

1<sup>st</sup> MLAS Project 2011 proposal:

MLAS Workshop 2011 for library associations in Central and Soth East European Region – building a strong library associations and establish a model for future cooperation.

MLAS project expected close collaboration with the Croatian Library Association.

Term of the event: February 2011 MLAS project budget: 4.000 EUR

### Brief description:

MLAS Workshop presentations, panels and discussions on how we could build strong library associations in the targeted region, the importance of regional communication and cooperation, fundraising and library advocacy practice. Discussions would focus on different library association advocacy experience in Central and South East European Region and how to establish successful model for future cooperation. Participants from several countries across the region would be invited to share their experiences and knowledge of working in library associations. There would be expected about 60 representatives from the national library associations of Croatia, Bosnia and Herzegovina, Serbia, Slovenia and Macedonia and also some representatives of the national associations from other European countries, some members of expert reference group working on who would deliver content BSLA Programme and members of IFLA MLAS Standing Committee from the BSLA program as well as discuss their own experiences with the regional attendees. MLAS SC conducted a similar workshop last year in conjunction with the President's meeting in Stellenbosch. MLAS SC followed up with an online evaluation survey and received verv high satisfaction scores across the board. In addition, the participants expressed their unanimous opinion that the SLAS SC should conduct more workshops of this type.

2<sup>nd</sup> MLAS Project 2011 proposal:

Library Advocacy best practice on the example of ALA and IFLA New Professionals Special Interest Group presentation at the biennial conference INFOS 2011 in Slovakia, attended by Central European library associations representatives.

MLAS project proposal expected close collaboration with the Slovak Librarians Association.

Term of the event: April or May 2011 MLAS project budget: 3.500 EUR

#### Brief description:

Central European librarianship has a specific need to host the official representatives from IFLA Sections to be able to attend the event directly in the region without any expensive travel costs and if possible translated to the local language. IFLA is a global voice of librarianship, but librarians from this region have not so many possibilities to travel and there is still a large language barrier, as most of librarians don't speak English. Understanding of the international trends depends on the mentioned factors. Therefore it would be very effective to use for this purpose the biennial conference INFOS held in Slovakia, attended by Central European library association representatives. The last IFLA event was held in Slovakia in 1978, when the IFLA Annual Conference / General Assembly took place at the High Tatra Mountains resort. This would be a symbolic comeback of IFLA to the same region after 33 years, giving the opportunity to talk about topics of international best practices of library advocacy and about involving new professionals in the international development of our profession in the digital world. Expected number of biennial conference participants is 150-170 from the following countries: Slovak Republic, Czech Republic, Hungary, Poland. Austria. Keynote speakers except the mentioned countries would be from USA and European countries. The conference programme includes the panel discussion and workshop to give opportunities for team discussions.

Silvia Stasselová/MLAS Secretary informed MLAS SC Mid-Term meeting participants that just the 1<sup>st</sup> MLAS Project proposal was supported by IFLA Professional Committee and its whole budget of 4.000 EUR was approved to organize MLAS Workshop 2011 in Split.

She expressed that thanks to this successful project MLAS SC could support the travel costs of Anna Popova from Bulgarian Library and Information Association, Alina Jaskuniene from Lithuanian Library Association and many representatives from Croatia, Serbia, Bosnia and Hercegovina and also Slovenia. The plan to support the travel costs of MLAS SC member Rosemary Gitachu was not possible to realize as she had problems with her visa to Croatia.

MLAS Secretary also informed that regardless the fact that the 2<sup>nd</sup> MLAS Project proposal was not approved by IFLA PC she is planning to invite as much MLAS SC members, MLAS representatives and Convenor of New Professionals SIG to attend the international symposium INFOS 2011 to be held in May 2011 in Slovakia to support the promotion of IFLA and MLAS activities and the role of library advocacy on the best practice of ALA in CEE countries.

The following speakers/MLAS representatives were invited by Silvia Stasselová/MLAS Secretary and the main organizer of INFOS 2011 international symposium: Marijana Misetić/President of Croatian Library Association, Gerald Leitner/CEO of Austrian Library Association and President of EBLIDA, Sebastian Wilke/NPSIG Convenor and Roberta Stevens/President of American Library Association (her 10 days visit to Slovakia was supported by US Embassy in Bratislava).

Another IFLA Project 2011 proposal "International Librarian Exchange" program (ILE) sent to IFLA PC with the support of MLAS after its short presentation by Sabine Stummeyer during MLAS SC meeting at IFLA 2010 Annual Conference was not supported by IFLA PC.

Tore Andersen, Hellen Niegaard, Barbara Schleihagen and Maria Cotera presented their innovative ideas to improve some financial procedures related to organizing next MLAS Workshops. Jennefer Nicholson and Barbara Schleihagen explained all conditions of financial procedures within IFLA, what was useful for all MLAS SC members.

Jennefer Nicholson/IFLA Secretary General recommended to transfer the rest of MLAS budget from the bank account of the Norwegian Library Association to IFLA HQ bank account after Tore Andersen/MLAS Treasures finish his MLAS service in August 2011.

Edita Bacic/MLAS SC member and MLAS Workshop 2011 local coordinator expressed her special thanks to President Hotel in Split, which reduced the conference room rental fees, to Split City Library and University in Split for organizing lunch for participants of MLAS events held in Split, what helped to reduce MLAS expences.

### **MLAS Information Coordinator's Report**

MLAS Secretary informed on updated MLAS website containing published minutes from all MLAS SC meetings and six MLAS Guidelines leaflets available to be downloaded. She recommended to correct one blind link to MLAS brochure, which was missing at MLAS website.

She recommended MLAS SC to promote the possibility to volunteer and translate MLAS guidelines to more languages among IFLA members, as these were the basic guidelines on how to run library associations sooner than IFLA BSLA Programme started and MLAS Guidelines are still very helpful in addition to BSLA Programme modern tools.

Silvia Stasselová/MLAS Secretary asked MLAS SC members on behalf of Sue Hutley/ MLAS Information Coordinator to send her contributions to the new issue of MLAS Newsletter. The last MLAS Newsletter 2010 is available online at MLAS website and it could inspire each MLAS SC member to publish information on any successful MLAS related activity or successful national or international library event anywhere worldwide.


## IFLA Update / IFLA 5 Key Initiatives

Janice Lachance expressed her thanks to Jennefer Nicholson/IFLA Secretary General for her attending of MLAS SC Mid-Term meeting what she expressed to be a privilege in a number of levels, also regarding the previous involvment of Jennefer Nicholson in MLAS Standing Committee in the past as representative of Australian Library Association before her IFLA HQ service at the current position of IFLA Secretary General.

Jennefer Nicholson/IFLA Secretary General introduced three IFLA Governing members present at MLAS SC meeting in Split: Sinikka Sipila, Barbara Schleihagen and Janice Lachance.

Janice Lachance expressed her thanks to Jennefer Nicholson/IFLA Secretary General for all her valuable information, especially on the model of MLAS involvement to IFLA 5 Key Iniciatives.

Hellen Niegaard mentioned that MLAS Workshop 2011 in Split will be in fact the third one as the first trial of MLAS Workshop was held during IFLA 2009 in Milan, Italy the year sooner than MLAS Workshop 2010 in Stellenbosch was held. She expressed her believe that organizing

MLAS Workshops is a useful way to share current leadership of perspectives. In addition to BSLA training programmes the MLAS GLAD Programme and "Stellenbosch model" are developing ongoing strong library associations.

The topics of MLAS and Key Initiative 2 "IFLA International Librarianship Leadership Development Programme" was discussed into details by Marian Koren, Barbara Schleihagen and Jennefer Nicholson/IFLA Secretary General.

Silvia Stasselová/MLAS Secretary asked Jennefer Nicholson/IFLA Secretary General on the perspective of the common international IFLA Code of Library Profession Ethics as the national Codes of Ethics published at IFLA website are very different by their content, length and their year of approval, some of them are very old and not suitable for the 21<sup>st</sup> Century.

IFLA Secretary General informed about the started cooperation of IFLA and International Society of Ethics 18 months ago already. Stuart Hamilton informed on the working group established to prepare the draft of the International Code of Ethics for the field of librarianship.

# Report on the Women, Information and Libraries Special Interest Group (WILSIG) Reporter: Maria Cotera, WILSIG Convenor

# Short report on WILSIG activities during IFLA WLIC 2010 in Gothenburg "Global Women's Fair: Sharing Best Practice in Support of Women Users, and Women Library and Information Workers".

Women, Information & Libraries SIG (WILSIG) held a successful off-site session on 13<sup>th</sup> August 2010 at the National Resource Library for Women's, Men's and Gender Studies, Gothenburg University. WILSIG off-site session was attended by approx. 80 delegates.

This was followed by a closing session with speakers Ellen Tise and Agnetta Olsson, who received the Strong Women Medal from a representative of the Strong Women Project, and a small reception to commemorate 20 years since the Women Issues RoundTtable was first created at the IFLA Congress in Sweden in 1990. WILSIG off-site session was sponsored by Gothenburg University Library which provided the venue, equipment, support staff and refreshments and printed leaflets and maps.

# WILSIG Satellite Pre-conference, IFLA WLIC in Puerto Rico 2011 "Information Literacy and its Impact on Women"

We are planning a joint pre-conference with Information Literacy Section at Turabo University, Puerto Rico (24kms Southeast of San Juan) on 11<sup>th</sup> -12<sup>th</sup> August 2011.

The WILSIG session will be held Tuesday 16<sup>th</sup> August 2011 from 16:00-18:00.

The session papers aim to provide case studies illustrating how libraries and information centres are responding to the needs of women around the world, providing services for the benefit of women, and helping them to survive the current world economic crisis.

### **WILSIG Satellite Pre-conference in Tampere 2012**

"How can libraries and information centres improve the accessibility and visibility of women's information and contribute to preserve women's cultural heritage"

Maria Cotera informed on planning a WILSIG pre-conference for 2012, in association with the Women Information Network Europe (WINE), the network of women's libraries, archives and information centres in Europe <a href="http://www.women.it/wine/index.htm">http://www.women.it/wine/index.htm</a>

The pre-conference is scheduled to open on Wed. 8<sup>th</sup> August early evening with a networking event and/or reception, and close on Friday 10th August at lunch time. It will take place at University of Tampere in Findland.

The satellite conference aims to discuss:

- ways libraries and information centres provide access to women and gender information
- ways they preserve women's cultural heritage
- the role of women's libraries and information centres in the internet era.

Janice Lachance/MLAS Chair asked MLAS SC members to confirm they agree with the planned WILSIG Pre-conference in 2012 in Tampere, what was confirmed unanimous.

Maria Cotera/WILSIG Convenor opened the discussion on the future of WILSIG as her role of WILSIG Convenor will finish soon and the next steps regarding SIG sustainability are needed. Stuart Hamilton informed on the updated IFLA BSLA new website since IFLA WLIC 2010 in Gothenburg, which includes:

- Training Packages Overview
- Policy-based learning materials
- Case studies

IFLA BSLA online learning plarform is available after registration and there is a growing interest in using this unique platform. # Association Membership Overview and status of associations sponsorship Reporter: Jennefer Nicholson, IFLA Secretary General

Janice Lachance/MLAS Chair asked to inform Jennefer Nicholson/IFLA Secretary General to inform MLAS SC Mid-Term Meeting participants on IFLA Association Membership Overview and status of associations sponsorship.

Jennefer Nicholson/IFLA Secretary General presented the proposal of a new membership category of *[National] Association Affiliate.* 

IFLA Statutes Article 6: Governing Board may give affiliate status to individuals, institutions and organisations that support the purposes of the Federation and may assess a fee or other conditions as given in the Rules of Procedure.

Currently have Institutional and Personal [Individual] affiliates [Rule 3]:

Shall pay an annual affiliation fee set by GB; GB may set different levels of fees for Affiliates in developing and developed countries;

Minimum level should cover the basic costs of membership;

GB may set fees for new Affiliates in selected low-income countries at a lower level if the Treasurer approves.

### Associations membership incentive:

- May not vote in elections for President-elect and elected places on the Governing Board;
- May speak but not vote at the General Assembly [are not included in the quorum]
- Have all other member services and entitlements

# Why this incentive proposal?

Would enrich IFLA and make it more inclusive and representative

Makes IFLA more credible as an international association

Makes it easier for emerging and small associations to join

Makes it easier for organisations to sponsor an emerging or small association

Would not disadvantage IFLA financial

### What is it?

- New band 13
- Operating expenses of less than €10,000 [same as Band 12]
- No voting rights
- No free sections [automatically have MLAS and their regional section membership included]

#### Fee basis?

Band 12 is €218

Deduct financial benefit of 2 free sections €104

Deduct entitlement to vote [priceless!]

Could compare with Student Affiliate €58 fee which includes the Adopt-a-student programme set up by Education and Training Section

# Update on GLAD programme and MLAS Wiki

Reporter: Hellen Niegaard

Hellen Niegaard informed MLAS SC Mid-Term Meeting participants that the planned joint BSLA &GLAD workshop planned prior to the 2011 Congress in Puerto Rico as discussed during IFLA WLIC 2010 in Gothenburg will be not realized this year.

There was not any progress related to wiki since IFLA WLIC 2010, so Hellen Niegaard recommended the deadline August 2011 for the final decision on its future, as this topic is still opened since 2007.

Janice Lachance/MLAS Chair expressed her impression that the Michael Keith Fiels vision was to run wiki in a "World Report" style place, where library associations could add more information than it is available at the world report form. MLAS Chair recommended to reevaluate the former idea from year 2006.

Hellen Niegaard, Maria Cotera, Stuart Hamilton and Barbara Schleihagen discussed the influence of the information technologies development which may cause that wiki could be replaced by other tool and recommended some ideas, for example to use BSLA platform.

### **Public Policy update**

Reporter: Stuart Hamilton, IFLA Senior Policy Advisor

Stuart Hamilton/IFLA Senior Policy Advisor informed on the last activities in cooperation with WIPO since the 21st Session of the World Intellectual Property Organisation Standing Committee on Copyright and Related Rights (SCCR) took place in Geneva on November 8-12, 2010. At the meeting's conclusion the SCCR agreed a work plan for 2011/12 concerning copyright exceptions and limitations which not only takes forward the proposal by Brazil, Ecuador, Paraguay and Mexico for the World Blind Union's (WBU) proposed 'Treaty for Improved Access for Blind, Visually Impaired and other Reading Disabled Persons , but additionally allocates equal time for "text-based work on appropriate exceptions and limitations" for libraries and archives, educational, teaching and research institutions, and persons with other disabilities.

Stuart Hamilton informed on the planned schedule of negotiations for the treaty which has many strong opponents.

He recommended attention to the key IFLA event on copyright related issues:

IFLA Presidential Meeting 2011 to be held in April 2011 in The Hague

"Libraries driving access to knowledge: Action for Europe" with 3 main themes:

- Access to information as a Human Right
   Planned outcome will be a statement relating to user privacy issues at the European level.
- Access and copyright
  Outcome will be the launch of the 'Library Treaty' planned to be introduced
  at the WIPO SCCR session on copyright exceptions and limitations in Geneva
  in November 2011
- Open access and the changing role of libraries
   Outcome will be the statement on Open Access
   (1st proposed by the President's Working Group in WLIC 2010)

"Copyright for library associations" workshop in Africa was held and others are planned to be organized especially in countries without appropriate copyright law.

Stuart Hamilton informed on the current internet legislation related issues in various countries.

Maria Cotera informed on the Library and Information Manifesto published by CILIP in 2010 "Six priorities fot he next Government" which can be used as a model for other library associations <a href="http://www.cilip.org.uk/get-involved/campaigning-toolkit/manifesto/Pages/default.aspx">http://www.cilip.org.uk/get-involved/campaigning-toolkit/manifesto/Pages/default.aspx</a>

Stuart Hamilton/IFLA Senior Policy Advisor highlited the necessity of close cooperation with MLAS.

# Planning of the next MLAS Workshop and MLAS SC Mid-Term Meeting in 2012 Moderator: Janice Lachance, MLAS Chair

Barbara Schleihagen highlited the impact of MLAS Workshops which bring more possibilities to local library association representatives who might not be able to attend IFLA WLIC conferences. Janice Lachance highly recommended to continue in idea of organizing MLAS workshops in relation to MLAS SC Mid-Term meetings. She mentioned the previous connection of the 1<sup>st</sup> MLAS Workshop with IFLA Presidential meeting and she asked IFLA Secretary General on the possible places of the coming IFLA Presidential meetings. 1<sup>st</sup> IFLA Presidential meeting of Ingrid Parent will be held in Vancouver, what probably would not the appropriate area with the need of MLAS Workshop 2012.

MLAS SC members discussed the best possible location to organize the MLAS Workshop 2012:

- Stuart Hamilton/IFLA Senior Policy Advisor recommended to combine MLAS Workshop 2012 with the already planned "Mini-Congress" for participants from the first 6 BSLA countries sponsored by IFLA and Bill & Melinda Gates Foundation. Barbara Schleihagen expressed she supports this idea.
- Maria Cotera recommended London in UK and offered a possible support of CILIP.
- Silvia Stasselová/MLAS Secretary recommended to organize MLAS Workshop 2012 in Lithuania, where librarians from more neighbouring countries Latvia, Estonia and Ukraine could be interested. Her recommendation was based on the information of Alina Jaskuniene, president of Lithuanian Library Association who attended MLAS SC Mid-Term meeting as observer and mentioned some problems at her library association. Lithuania is also one of the supported BSLA country projects in 2011. The recommended area is very close to Helsinki, where IFLA WLIC 2012 will be held.

Jennefer Nicholson recommended to look after the MLAS Workshop location, where some additional funding could be possible. Janice Lachance/MLAS Chair announced the final MLAS Workshop 2012 location decision during the next MLAS SC meeting during IFLA WLIC 2011 in Puerto Rico.

# **Update of MLAS Strategic Plan**

MLAS SC members were asked to send their comments to MLAS Strategic Plan by email before MLAS Mid-Term meeting in Split. As only NPSIG sent their comments, this request on cooperation to finalize the update of MLAS Strategic Plan still continues. Janice Lachance/ MLAS Chair asked MLAS SC members for their kind cooperation and send their valuable comments to MLAS Secretary.

### Closing Statement by Janice Lachance, MLAS Chair

MLAS Chair expressed her gratitude to all MLAS SC members, guests and observers for their attending the MLAS Mid-Term Meeting in Split and expressed her wish to meet all MLAS Standing Committee members at MLAS SC Meeting during IFLA WLIC 2011 in San Juan, Puerto Rico.
